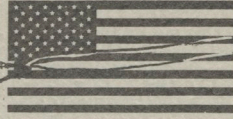

JAMES J. ALFINI, assistant executive director of the American Judicature Society, is co-author of *Making Jury Instructions Understandable* to be published this fall by Michie/Bobbs/Merrill. He has published a number of articles in the field of judicial administration.

SHIRLEY CASTELNUOVO, professor of Political Science at Northeastern Illinois University, has published a number of articles in the field of law and social change. These works include: "Public Interest Law and the Crisis of Legitimacy," "A Human Nature Paradigm: An Alternative Way to Thinking About Social Change." Dr. Castelnovo is conference co-director.

ROGER DANIELS, chairperson of the Department of History at the University of Cincinnati, is a recognized authority on the events relating to the relocation and internment of Japanese-Americans during World War II. Dr. Daniels is the author of *Concentration Camps U.S.A.: Japanese-Americans and World War II* and *The Decision to Relocate the Japanese-Americans*.

ARTHUR J. GOLDBERG, former secretary of labor, associate justice of the Supreme Court, United States representative to the United Nations, and ambassador-at-large for the United States, is president of the American Jewish Committee and member of the Commission on Wartime Relocation and Internment of Civilians.

WILLIAM HOHRI is the national chairperson of the National Council for Japanese-American Redress.

STANLEY I. KUTLER, the E. Gordon Fox Professor of American Institutions at the University of Wisconsin, is the author of *Privilege and Creative Destruction* and *The Supreme Court and the Constitution*. His most recent publication is "Forging a Legend: The Treason of 'Tokyo Rose'."

DANIEL KUZUHARA, assistant professor of Psychology at Northeastern Illinois University, is head of the university's Project Hope and co-coordinator of the Adulthood and Aging Studies program. His research interests are in psycho-cultural studies. Mr. Kuzuhara is conference co-director.

MINORU YASUI, executive director of the Commission on Community Relations, city and county of Denver, is chairperson of the National Redress Committee of the Japanese-American Citizens League.

REVEREND SEIICHI MICHAEL YASUTAKE, chairperson of the Midwest District Council Human Rights Committee of the Japanese-American Citizens League, is an Episcopal priest.

MARIA MORAITES-SATO, assistant professor of Learning Services at Northeastern Illinois University, has produced and directed educational films. Among her most recent productions is "American Women: Daughters of a Dream."
