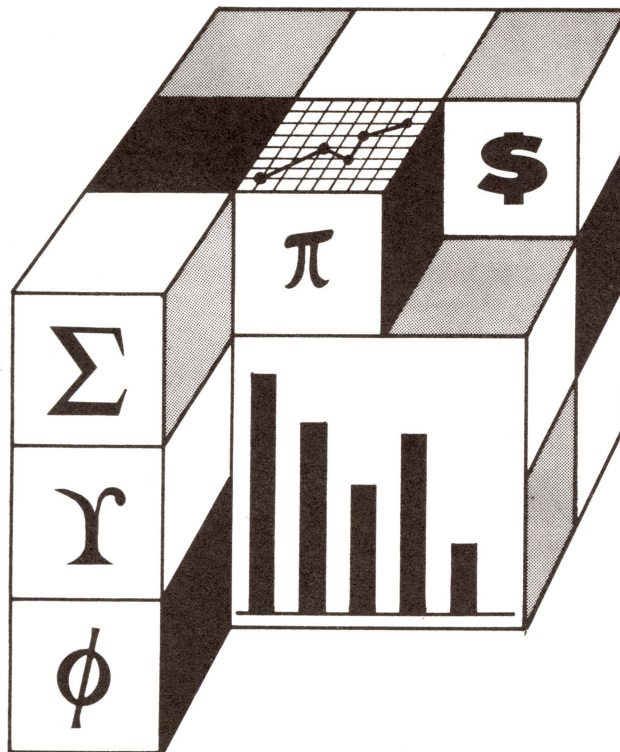

## NORTHEASTERN AWARDS SCHOLARSHIPS TO FUTURE TEACHERS

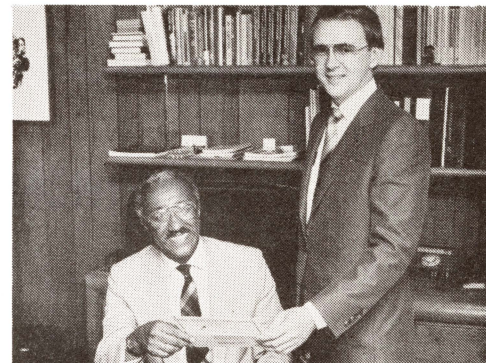
Scholarships were recently awarded to eight students in the College of Education. The eight, all graduates of Chicago public high schools, were recipients of the Chicagoland Educational Film Festival's "Golden Babe Scholarship Award." The scholarships were established by Fred Rosengarden, director of visual education for the Chicago Board of Education, in memory of his wife.

Since 1978, Northeastern Illinois University and the Chicago Board of Education have co-sponsored the annual Chicagoland Educational Film Festival each fall on the university's campus. The festival enables the public to evaluate those educational films that are under consideration for use in Chicago's public schools.

The eight scholarship recipients are Catherine Buck, a graduate of Schurz High School; Belinda Carlie, a graduate of Farragut High School; Daniel Dillon, a graduate of Foreman High School; Betty Holmberg, a graduate of Amundsen High School; Susan Michelle Jordan, a graduate of Taft High School; Andriana Pantazelos, a graduate of Roosevelt High School; Angel Vasquez, a graduate of Calvin Park High School; and Catherine Zanon, a graduate of Steinmetz High School.

Dr. Ahmed Fareed, dean of Northeastern's College of Education, said the scholarship recipients were selected based on their "commitment to education. The recipients of these scholarships have demonstrated the calibre of excellence and affection for education that will be needed to face the future challenges in teaching."

### 1982 FACULTY OF THE YEAR

In order to be eligible for this award, a faculty member must demonstrate strong dedication to Northeastern, his/her students, as well as the pursuit of academic excellence. Dr. Alfred Robinson, Jr., Division of Business and Management, was chosen by the April, August, and December 1982 graduating classes as being an outstanding teacher and for his active involvement and concern for university, faculty, and student affairs.

### ALUMNI MERIT AWARD

Libby Komaiko Fleming (B.A., 1977, university without walls) received this award for her outstanding work with the dance program at Northeastern and for establishing the Ensemble Español, a Spanish in-residence dance company, on the university campus. In addition, Libby founded, organized, and directed the American Spanish Dance Festival which is now in its fourth year.

Michael R. Lyons (B.A., 1977, political science; M.A., 1978, political science) was recognized for his work as chief investigator for the Better Government Association of Chicago. Mike has been a coordinator of

the NBC Magazine investigation of Medicare Fraud, investigated "Foster Care Drift," and was coordinator of the "20-20 - Arson for Profit" investigation in addition to other numerous activities.

Dorothy M. Miaso (B.A., 1973, English) was cited for her position as director of Senior Programs in the governor's office. Dorothy has worked on a number of social service projects for senior citizens here at the university as well as in the metropolitan Chicago area.

### ALUMNI SERVICE AWARD

Yvonne King (B.A., 1976, university without walls) received this award for her work in facilitating the University Without Walls degree program's efforts to develop degree opportunities for the incarcerated. She has negotiated with prison officials to offer prison inmates opportunities for higher education and is currently serving as a liaison to the prison community by counseling perspective students.

### ALUMNI SPECIAL AWARD

Dr. George R. Lesmes, Department of Health, Physical Education, Recreation, and Athletics, was selected for his outstanding work in the creation of the human performance laboratory, initiation of the Adult Fitness Program, research into sports medicine, and the development of a master's degree in exercise physiology and cardiac rehabilitation.

Dr. William J. Pizzi, Department of Psychology, received this award as a result of his accomplishments as director of the neuropsychology laboratory. Dr. Pizzi has published several research articles and has presented numerous papers on neuropsychology.

Michael B. Murphy (B.A., 1979, kaskaskia) was the recipient of this special certificate in recognition of his support to both university and association programs.

# NORTHEASTERN'S COLLEGE OF BUSINESS AND MANAGEMENT: MERGING TECHNOLOGY AND ECONOMICS WITH HUMAN POTENTIAL

Ronald Williams, president of Northeastern Illinois University, announced on July 1 the establishment of the university's third undergraduate college, a College of Business and Management. President Williams said the new college, with an enrollment of approximately 2,100 students, was established after receiving formal approval from the Board of Governors of State Colleges and Universities and from the Illinois Board of Higher Education. Dr. Olga Engelhardt, a nationally-recognized expert in organizational and business psychology, has been named dean of the new college.

"The establishment of a College of Business and Management at Northeastern mirrors our university's commitment to provide academic access and excellence to Chicago area residents," said President Williams. "Our objectives for the college are twofold. Not only do we want to prepare students who are well-educated in the science of business and management theory, structure, and function, but we also want to provide our business students with a strong liberal arts foundation so that they may have an understanding of human achievement and potential and a commitment to the technological, economic and social advancement of our nation's urban areas."

Dr. Engelhardt said that three academic departments have been formed within the new business college. They are the Department of Accounting, Business Law, and Finance, the Department of Management, and the Department of Marketing. The five undergraduate degrees to be offered by the college are Bachelor of Science in Accounting, Bachelor of Science in Finance, Bachelor of Science in Management, Bachelor of Science in Marketing, and Bachelor of Science in General Business Administration.

"One of the major strengths of our business college is the designation of our degree programs," explained Dr. Engelhardt. Northeastern will become one of the few universities in the Midwest to specifically designate fields of study in the bachelor of science degree title. "This designation will indicate to potential employers that students graduating from Northeastern's College of Business and Management were educated in a well-structured program that stresses specialization in one of the various fields of business study."

Dr. Engelhardt said the establishment of the College of Business and Management adds status to the university's academic programs in business. "We believe our students will now be in a better position to compete with graduates from other colleges of business for jobs in the corporate and public sector," she said. "For marketability, it is advantageous for our students to be able to say they graduated from a College of Business and Management. The designation as a college enhances the university's stature in the business and academic communities and adds credence to the research efforts of our faculty as they prepare articles for professional publications or papers for academic conferences and conventions."

Most courses offered in the new college are upper division (300 or 400-level). During their first two years of college, students planning to major in business and management are encouraged to develop a strong foundation in the liberal arts. Admission to the College of Business and Management is open only to those students who have attained a 3.5 grade point average. To gain admission, students must have received a grade of "B" or better in finite mathematics, English composition, and statistics. Students who pass competency tests in any or all of those three courses will also be admitted. The College of Business and Management requires that candidates for admission must receive a grade of "C" or better in the introductory accounting course. To graduate from the college, students must maintain at least a 3.5 grade point average in their major field of study.

"Because there is a student demand for admission to our college, we have the opportunity to select promising students," Dr. Engelhardt said. "As a result, classes in business and management tend to be academically challenging and stimulating for both the students and the professors."

Northeastern first began offering courses in business and management in 1974. A Division of Business and Management was developed in 1979 as part of the university's long-range plans to eventually develop an undergraduate College of Business and Management. Dr. Engelhardt served as director of the division before being named dean of the new college.

Other colleges at the university are the Graduate College, the College of Education, and the College of Arts and Sciences. Undergraduate degrees are also offered through the Center for Program Development, the university's administrative unit for all non-traditional undergraduate degree programs.

## COLLEGE'S DEPARTMENTS EMPHASIZE BUSINESS THEORY, CAREER PREPARATION

The three academic departments that form the new College of Business and Management emphasize coursework that provides students with a theoretical base in business as well as those skills necessary for career advancement. The three academic departments in the College of Business and Management are:

### Department of Accounting, Business Law, and Finance

The Department of Accounting, Business Law, and Finance prepares students for careers in accounting and finance while providing all business majors with a solid background in accounting, finance, and business law. Majors within the department pursue degree programs leading to either a Bachelor of Science in Accounting or a Bachelor of Science in Finance. Minors can be declared in accounting, business law, or finance.

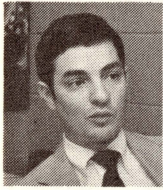
Dean Engelhardt said that upon graduation students majoring in accounting usually pursue entry level positions in public and private accounting firms and financial offices, or accounting positions in small and large business concerns or in the public sector.

She said that finance graduates usually pursue entry level positions in the financial markets or financial management. Future career opportunities for these students include jobs as financial analysts, bank managers, stockbrokers, commodity traders, or portfolio managers.

Mr. Ralph Collins Walter III, an assistant professor of finance, has been named the first chairperson of the Department of Accounting, Business Law, and Finance. Before joining Northeastern's faculty in 1982, Mr. Walter was vice-president for corporate planning at Dean Witter Reynolds with responsibility for the appropriation and analysis of the firm's strategic and operational business plans. He has also worked for A. G. Becker, Inc. as a senior financial partner and has taught statistics at Indiana University.



## Department of Management

The Department of Management offers courses leading to Bachelor of Science degrees in either Management or General Business Administration. Dean Engelhardt said that courses offered by the department provide a background in the study of individuals in organizations, small groups, and larger organizations in their entirety. She said that management courses serve to broaden a student's understanding of their own current or future role in the workforce and provide an essential background in management functions for those students preparing for a business career.

Students graduating with undergraduate degrees in management can obtain entry level positions as production supervisors, personnel recruiters, employment interviewers, labor relations assistants, salary and wage administrators, hotel and motel managers, credit managers, and management trainees in a variety of business and industrial companies.

The first chairperson of the Department of Management is Dr. William Macey, an associate professor of management. In addition to his teaching activities at Northeastern, Dr. Macey is president of Personnel Research Associates, Inc., a consulting firm to major industries. The firm specializes in test development and validation, manpower planning, performance appraisal systems design, training needs analysis and program design, equal opportunity and affirmative action, wage and salary administration, and program evaluation.

Dr. Macey also served as human resources planning coordinator for the Miller Brewing Company and as a faculty member at the Illinois Institute of Technology and North Central College.

## Department of Marketing

"Marketing is an essential part of any business organization because it deals with developing products, services, and ideas which meet needs and wants," said Dean Engelhardt. Northeastern's Department of Marketing offers a curriculum designed to provide students with a firm foundation in the basic concepts of marketing through courses in principles of marketing, consumer behavior, marketing research, and marketing management and allows students to explore further areas of special interest within the field of marketing.

Majors in the department receive a Bachelor of Science degree in Marketing upon graduation. Students are also offered the option to pursue a minor field of study in marketing.

Dean Engelhardt said that students graduating from the program are qualified to pursue entry level positions in sales, retailing, product management, market research, advertising, and purchasing.

Ms. Judy Cohen, an assistant professor of marketing, has been selected as the first chairperson of the Department of Marketing. Before joining Northeastern's faculty in 1981, Ms. Cohen served on the faculty of Syracuse University. She has concentrated most of her research activities on macromarketing.

## DR. ENGELHARDT APPOINTED DEAN

Dr. Olga E. Engelhardt has been named dean of the newly formed College of Business and Management at Northeastern Illinois University. Dr. Engelhardt had served as director of the university's Division of Business and Management since 1981.

Prior to coming to Northeastern, Dr. Engelhardt was chairperson and professor of the Division of Social and Behavioral Sciences at North Central College in Naperville. During her 30 years of teaching and administration, she has served on the faculties of the University of Connecticut in Storrs, Valparaiso University, and the University of Chicago.

In addition to teaching, Dr. Engelhardt has devoted her time to research in psychology, psychological consulting on consumer surveys, design, implementation, and evaluation of training programs in costs and productivity and managerial skills for supervisory and middle management, and executive seminars on subjects such as training needs, current managerial innovations, reassignment, retraining, and termination. Her consulting has been with national companies in the food, beverage, lumber, and steel industries.

Dr. Engelhardt was awarded her bachelor of arts degree from Hunter College in New York. She received her master of arts and doctorate degrees from Columbia University in New York and has pursued post-doctoral work at Northwestern University as a Visiting Scholar and as a Post-Doctoral Fellow in Evaluation Research. She was also selected by the Lilly Foundation as a Post-Doctoral Fellow in Illuminative Evaluation at Colorado College.

In 1978, North Central College presented Dr. Engelhardt with its first Clarence F. Dissinger Memorial Fund Faculty Award for Distinguished Teaching. She received the Psi Chi (a national honor society) Award at the 1982 annual convention of the American Psychological Association for her outstanding contributions to the national honor society.

Dr. Engelhardt has presented papers at meetings of the Eastern Psychological Association, the Psychonomic Society, and the American Psychological Association. At a symposium on "Eminent Women in Psychology" in Washington, D.C., last year, she was invited to present a paper entitled "In Retrospect: The Career Path of an Industrial/Organizational Psychologist."

She has also written a book, a monograph, and several articles for professional journals. She is a fellow of the American Association for the Advancement of Science, American Psychological Association, and Society of the Sigma XI and a member of the Psychonomic Society, Academy of Management, Evaluation Research Society, Midwestern Psychological Association, Midwest Business Administration Association, Psi Chi, Greater Chicago Association of Industrial/Organizational Psychology, and the Illinois Council of Business Deans.

Dean Engelhardt is listed in the *Directory of the American Psychological Association, Who's Who in the Midwest, and American Men and Women of Science: Social and Behavioral Sciences.*



# Grants, Grants GRANTS

Ravenswood Hospital Medical Center School of Nursing has contracted with Northeastern for five undergraduate course offerings during the 1983-1984 academic year: two in zoology; one in biology; one in psychology; and one in nutrition and health. These courses are for credit and are open only to the hospital's nursing students. Facilities at both the university and the hospital will be utilized. The offering of courses tailored to the needs and limited to students of a contracting agency is an approach recently approved for public universities. These are the first "educational contracts" entered into under the new procedure. Project director is Dr. Herbert Lamp, acting associate dean of the College of Arts and Sciences.

An award of \$40,054 has been received from the U.S. Department of Education for a new project, **Preparation of New Special Education Supervisory Personnel**, which will prepare students at the masters degree level for supervisory positions in special education. Program trainees will complete masters level courses, including specific additional work in administration and supervision, to be eligible for the Supervisory Endorsement in Special Education in one of the following areas: Trainable Mentally Handicapped (TMH); Behavioral Disorders (BD); Educable Mentally Handicapped (EMH); or Learning Disabilities (LD). Project director is Dr. Levi Lathen, Department of Special Education.

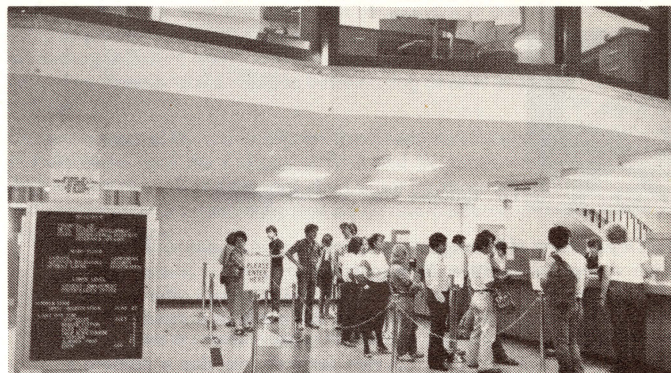
Continuation funding for the **Special Education Masters Degree Program Assistance** grant was received from the U.S. Department of Education. This new award of \$64,124 will support the second year of the new three-year grant which prepares personnel at the masters degree level to meet three high priority needs for the state of Illinois: Early Childhood Special Education which prepares certified primary, elementary, and/or special educators at the masters degree level to work with handicapped children, ages 0-6; General Special Education (Vocational/Career) which prepares special education teachers to work with handicapped adolescents in need of vocational/career education; and Severe Handicapped Education, preparing teachers at the masters degree level to work with severely handicapped children. Project director is Dr. Janet Lerner, chairperson of the Department of Special Education.

The Illinois Department of Transportation has increased the **Motorcycle Safety Program** grant by \$12,179; the 1983 award now totals \$209,009. The program provides Illinois residents with 20 hours of free instruction and includes use of motorcycles and protective headgear. The added funds will permit additional Experienced Rider courses; a Motorized Pedalcycle Rider course, staff travel to a Motorcycle Safety Foundation conference, and purchase of equipment and films. Project director is Ms. Marjorie Jennings, Department of Health, Physical Education, Recreation, and Athletics.

Assistance for a national conference on black women, **Black Womanhood: A New Ideology, A New Mandate**, has been received from several sources: The city of Chicago's Department of Human Services will be supporting \$100 registration fees for sixty participants; and the Center for New Horizons has contributed \$980 for registration fees for their staff. Grants of \$1,000 from the Avon Foundation and \$300 from the South Shore Bank also have been received. In addition, technical assistance is being provided by the Community Renewal Society. The conference, to be held on October 26-29, 1983 at the McCormick Inn in Chicago, will bring together a national cross-section of black women to explore the socioeconomic and political issues that inhibit their personal and professional growth, and to develop relevant strategies to resolve these issues. Project director is Ms. Ayana Johnson, Center for Inner City Studies.

The library received a grant of \$890 from the **College Library Resources Program**, administered by the U.S. Department of Education. The formula award permits the acquisition of books, periodicals, audio-visual, and other materials. Project director is Dr. Melvin George, University Librarian.

## ADMINISTRATIVE CENTER

Alumni from the 60's may have a tough time recognizing the Old Library these days. With the opening of the "new" Library in 1977, the former Library has undergone a series of remodeling projects which have brought together several university offices.

The Office of Admissions and Records is now housed in what was formerly the documents room and the old periodicals room is occupied by the Business Office. The Office of Financial Aid, located on the mezzanine, was formerly used as the curriculum materials center. What once served as the 'stacks' in the basement is now being occupied by the Controller's Office, Student Employment Office, General Stores, Duplicating, and Mail Service.

By centrally locating these offices, students spend less time running around campus when it comes time to register and pay tuition bills. The one special challenge that accompanied the relocation was what to call this area. After much thought and deliberation, "Administrative Center" has been chosen. However, to some, it will always be the Old Library.

## DEAF-BLIND WOMAN BECOMES AN ALUMNA

At the June 12 commencement exercises at Medinah Temple, Geraldine Lawhorn did not see the diploma she received from President Williams. Nor did she see or hear the standing ovation and cheers she received from her fellow students.

On that day, Geraldine became the sixth deaf and blind person in the United States to receive a college degree. Other deaf-blind persons who have earned college degrees include Helen Keller and Richard Kinney, a past president of the Hadley School for the Blind in suburban Winnetka.

Blind since the age of 10 and deaf since 19, Geraldine has worked as a pianist, actress, lecturer, and teacher for more than 40 of her 67 years. She is a gentle witty woman who radiates a quiet self confidence. Thanks to much coaching and practicing after the onset of her deafness, she has a pleasant and distinct speaking voice.

Geraldine studied acting, dancing, and piano in Chicago and New York. For many years, her mother served as her interpreter. They lived together for 20 years in New York and it was there that she began to perform professionally, presenting piano and dramatic recitals. She wrote many of her own dramatic monologues. She performed at Carnegie Hall and in 1955, she received the "Best One-Woman Show Award" from *Show Business* magazine.

Chairwoman of the Department of the Deaf-Blind at the Hadley School for the Blind, Lawhorn teaches "Independent Living for the Deaf-Blind" and "Verse Writing" through correspondence courses. She also works with the Hadley School's public relations department by speaking to groups about the school's activities.

Geraldine earned her bachelor of arts degree in rehabilitation of the deaf-blind through Northeastern's University Without Walls program which incorporates on- and off-campus learning experiences, including work-related activities. Under the guidance of Warren Haushalter, her academic advisor at Northeastern, and Arlin Antman, her community advisor and an instructor at the Hadley School, Lawhorn studies many subjects that will help her in her work with the deaf-blind.

"Our University Without Walls program was well suited for someone like Gerry since a traditional classroom setting would only slow down the learning process for her," said Mr. Warren. "Her warm personality and great sense of humor, along with her own life experiences, make Gerry an ideal person to help other deaf-blind individuals to live independently.

Central to all that she has been able to achieve is her ability to communicate. "I communicate with different people in different ways," she explained. "I use finger spelling, palm printing, a special glove with the alphabet on it, an alphabet card, and tellatouch, a small machine that produces braille with the use of a standard typewriter keyboard. With those who do not know finger spelling, I most often use the tellatouch machine or the alphabet glove."

For the last few years, Geraldine has also used an optacon, an electronic reading device that enables her to read ordinary print material. Thus, she is able to read all of her print mail and to proofread her own typing.

She is currently at work on her autobiography, *While It is Day*. "I believe it will be of interest to professionals who work with deaf-blind students, the deaf-blind themselves, and members of the general public who are curious about how I've lived my life," she said.

Reflecting on her many achievements and her hopes for the future, Geraldine said, "Religion has helped to take away a great deal of fear in my life. I have faith in myself and in a divine intelligence. And of course, I must always acknowledge the loving people around me who supply me with the information I need so that I can achieve what I want to achieve."

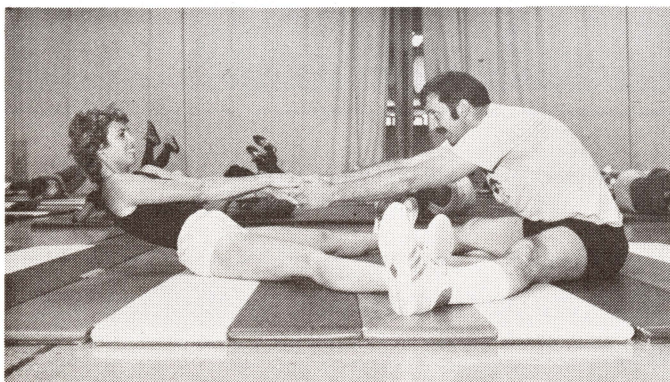
