## OFFICIALS FEAR PROPOSED HIGHER ED CUTS WILL HURT MINORITY/ADULT STUDENTS

he chancellor and the presidents of the Board of Governors Universities (BGU) (Northeastern Illinois, Chicago State, Governors State, Western Illinois, Eastern Illinois) recently stated that any program and service cuts made over the next year will be made with careful consideration of their impact on minority student access and success.

"Our five universities enroll more African-American and Hispanic students than any other public university system in this state," said Chancellor Thomas D. Layzell. "We have a long time commitment to providing access and quality education to these students and cannot suddenly cut off opportunities and support services."

Northeastern's President Gordon H. Lamb reiterated the need to continue serving not only minority, but adult students. "Most of our students are simply unable to relocate in order to pursue a bachelor's or master's degree. We must be able to provide a solid liberal arts background to these students, as well as a range of choices in career opportunities," Dr. Lamb stated.

NEIU's enrollment is about 35 percent minority. More than 75 percent of its students are not the traditional 18 to 21 year-old college age; nearly half are 30 or older, with the average undergraduate age being about 27.

BGU Chancellor Layzell and University Presidents Lamb, Dolores Cross, David Jorns, Paula Wolff, and Ralph Wagoner, face decisions on over 40 degree programs recommended for elimination by the Illinois Board of Higher Education (IBHE) under the Priorities, Quality and Productivity (PQP) initiative.

Layzell said faculty, staff, and students will be involved in the process every step of the way and will play a major part in determining where reductions will be made and resources reallocated. He added that all of the IBHE's recommendations will be carefully considered over the next year and none of the targeted programs are regarded as off limits at this point.

## NEIU FOUNDATION SPONSORS ANNUAL FUNDRAISING DINNER

Each spring, the Northeastern Illinois University Foundation Board of Directors honors an individual at their Recognition Dinner who has exhibited leadership and personal commitment to improving education in Illinois. This year's honoree is Dennis A. Britton, editorial and executive vice president of the *Chicago Sun-Times*.

The Annual Recognition Dinner is scheduled for Saturday, May 22, 1993, at the Fairmont Hotel. A stimulating evening has been planned, which includes a silent auction featuring many exquisite and spectacular items. The proceeds from this event will be used to fund the NEIU Minority Scholarship Program and provide small grants to faculty for research or scholarly projects. Under the leadership of Mr. Britton, the Chicago Sun-Times supports many educational and literacy programs such the Adopt-a-School Program, the Chicago Public School Science Fair, the Literacy Walk-a-Thon, and various scholarship programs for college students. Tables of 10 are available for \$2500, which is the Golden Eagles table, or \$1500 for a corporate table. Individual tickets for \$150 are also available. This is an excellent opportunity to network with Chicago area businesses and organizations in addition to other alumni.

Layzell said the IBHE recommendation to shift more funds into instruction is already being implemented. Two BGU institutions, Western Illinois and Governors State, currently have the largest percentage of funds expended for instruction of all public universities in Illinois.

"If our objective in this exercise is to make undergraduate instruction the top priority, then funding support for that objective must be part of the PQP discussion," said Layzell. "This is the time to consider redistributing higher education resources. The institutions demonstrating a commitment to the PQP process and results that are substantive, timely, and most consistent with state priorities should be rewarded."


Topics for the remainder of the year include federal laws, the attention deficit child, drugs and gangs, environmental and health issues, and review of what to do for the second year of teaching.


## "Dinner At Eight" **A Business Etiquette** Seminar

## **Campus Remodeling Projects Slated To Begin**



Illinois Governor James Edgar recently announced the release of approximately \$10.9 million in state funds for improvements at Northeastern. Construction bonds are providing the funding for these improvements which include the following construction projects.

• Design phase of the renovation of the Auditorium and G-Building to house the fine/performing arts programs for the Art, Music, Speech and Performing Arts departments. The total cost of this project is approximately \$19 million. Actual construction in this area is to begin early next year and be completed by 1996, assuming that additional funds are released once the design is completed.

## Touchtone Registration **Available** To Students

Northeastern's Admissions and Records Office recently unveiled the Touchtone Telephone Registration System (TTRS). This system enables students to register for courses, drop a course, select a course on pass/fail, listen to their class schedule, review open course sections, and review tuition and fee information.

One significant advantage of the TTRS system is that students know immediately if a course they wish to register for is available. In addition, at the completion of a student's call, their schedule and the amount of tuition owed will be known.

After several pilots and subsequent modifications to the system, including the installation of additional phone lines, the TTRS was implemented for the Spring 1993 advance registration. Over 7000 students advance registered. Those who didn't registered on campus.

Northeastern will continue to evaluate TTRS to determine how to proceed with future registrations; however, the goal is to eventually utilize TTRS for all registrations.

### Job And Career Fairs Assist In Networking

A significant number of Northeastern graduates report that they secured their position from networking through friends, relatives, and various professional contacts. Another way to seek employment is to "network" at Job and Career Fairs.

In the 1970s and early 1980s, these events have become established as an important mechanism for job seekers and corporate representatives to interface with one another. Clearly it is cost effective for the company because they can meet and screen several hundred candidates in one day. For the applicant, it is equally productive to meet with 10 to 15 potential employers at one place in one day.

The "interview" at a major Job/Career Fair is much different from a traditional closed door 30-minute interview. It is likely to last only four to five minutes and be conducted with a line of applicants behind the person being interviewed. In order to be successful, it is necessary to prepare for this specific type of interview, which is a "screening" interview for both sides.

Northeastern's Placement Director, Lorn Coleman, suggests the following general tips for success at Job and Career Fairs:

- 1. Always verify a Job Fair event with the host site (hotel, hall, etc.) several days prior to attending. Sometimes job fairs are scheduled six to nine months in advance. Arrive as early as possible. You will probably do your best when both you and the interviewers are 'fresh.' Expect lines.
- 2. Identify the companies you most desire to talk with before the event. Proceed to those on your "top 10" list first.
- 3. Remember that you will only have four to six minutes with the interviewer. It is a preliminary interview and will not be in-depth.
- 4. Ask meaningful questions that will help you ascertain whether you will have further interest in the company. They will be trying to ascertain the same about you.
- 5. Fairs are an excellent way of making contacts for future reference, not just for immediate openings. Collect business cards, names, addresses, and phone numbers.
- 6. Be able to state what it is you are interested in to the interviewer. Be able to talk about yourself with flexibility; don't memorize a set speech.
- 7. The Placement Office and the Sunday Chicago

Prior to the workshop, participants will receive a checklist of over 40 obstacles to complete for discussion that evening This will enable Dr. Helfand to address specific obstacles to those attending.

Involving three high schools and nine elementary feeder schools, this on-going program identifies students who are placed in early intervention programs. Program components include: 1) curriculum emphasizing higher order skills and opportunities for accelerated learning; 2) attendance monitoring and outreach; 3) family outreach and training; 4) counseling and social services; and 5) career awareness and preparation.

#### **Improving High School Transition for Inner-City Students: The University Scholars Program**

This cooperative program with Roosevelt University is a continuing enrichment program for 200 college-bound minority students from Crane and Lake View High Schools.

## Vivian L. Fuller Selected As Athletic Director

Last fall, Dr. Vivian L. Fuller began her duties as athletic director at Northeastern. She joined the small but growing number of women (and even fewer minority women) to head an NCAA (National Collegiate Athletics Association) Division I program.

"We're very pleased about having Dr. Fuller here as we enter our third year in Division I," said NEIU President Gordon H. Lamb. "She is a dynamic and respected leader who demonstrates a deep commitment to the academic integrity of intercollegiate athletics. She has an exceptionally strong academic background which includes teaching in addition to her wide-ranging experience in sports management, coaching, and academic advisement. She understands the complex issues and social concerns facing both student-athletes and universities in intercollegiate athletics today. In short, Dr. Fuller is exactly the kind of professional we need to manage our Athletic, Intramural and Recreation program."

Fuller comes to Northeastern after spending the past five years as associate director of athletics at Indiana University of Pennsylvania, which has an NCAA Division II program. Fuller expressed enthusiasm about taking over the Golden Eagles program and "putting Northeastern on the athletic map now that my predecessor Dr. Keihn has laid a solid foundation and President Lamb and the administration have demonstrated their commitment to Division I." She feels that Northeastern "has a good staff and supportive people in key positions to allow us to do some positive things," citing fund raising and community relations as areas where she can make progress.

Fuller received her doctorate in higher education administration from Iowa State University in 1985. She earned her master of education in 1978 from the University of Idaho and her bachelor of science degree in health, physical education, and recreation from Fayetteville State University in 1977.

Fuller served as the assistant director of athletics at North Carolina A & T University from 1984-1987. During her career in athletics, Fuller has held several positions including volleyball and softball coach, assistant professor, assistant director for advisement, and director of intramurals. Over the


past six years she has made over 20 national, regional, and local professional presentations on athletic administration, minorities in athletics and higher education, and women in athletics and higher education.

Fuller is also the chairperson for the National Youth Sports Program (NYSP). Under the auspices of the NCAA, the NYSP helped sponsor programs on college campuses for economically disadvantaged youth between the ages of 10-16, which brought them to college campuses to experience options of higher education through various programs.




