### PROFESSOR MORTON QUESTIONS LOPEZ' CAPABILITY

It has come to the attention of the Union for Puerto Rican Students (U.P.R.S.) that History Department Chairperson Joseph Morton has questioned Professor Lopez's capability to teach in the Criminal Justice Department. It is hypocritical of Mr. Morton to question any affair concerning Professor Lopez since it was he and his reactionary clique in the History Department who forced Mr. Lopez out.

As Chairperson of the History Department, Joseph Morton has enough problems and mistakes to hide (like Ignacio Mendez) than to meddle into affairs which are out of his control or jurisdiction. We understand that victory can sometimes taste bitter to forces of reaction and the return of Professor Jose Lopez has returned the bitter taste of fear not only to Joseph Morton, but to the rest of the racist clique at U.N.I.

### ROSIE SANTIAGO — STALLS — PUTS SOCIOLOGY CLUB BUDGET IN LIMBO!

After a three month wait, the Independent Club Board (I.C.B.) left the Sociology Club without a budget on Sept.16,1982. This means that the Sociology Club will be without a budget for one fiscal year.

The reason behind the freeze of funds by the I.C.B. was that the activities sponsored by the Sociology Club are "too political" and that they do not correspond to the Sociology Club's constitution. This same reactionary maneuver was implied by I.C.B. Chairperson Rosie Santiago whose unwillingness to break a deadlock in the vote to pass the budget resulted in an abstained vote, thus freezing the funds allocated to the Sociology Club for one year.

Acts such as the aforementioned, that are committed by Uncle Toms and 'Vendepatrias' such as Ronald Williams, Samuel Betances, and newly recruited Rosie Santiago serve to stymie and cripple the student struggle at U.N.I.

If Rosie Santiago has decided to side totally with U.N.I.'s racist reactionary forces, then she will be

exposed like any other Uncle Tom or latino opportunist on campus.

We, Que Ondee Sola, denounce Rosie Santiago's spineless and unprincipled act because, it served as a vantage point for the administration in its attempts to destroy the student movement at U.N.I.
