ARCHIBALD COX LECTURES MARCH 8

Archibald Cox, professor emeritus of law at Harvard University, and former Watergate special prosecutor, will lecture on Tuesday, March 8, at 7:30 p.m., in Alumni Hall. Cox, who was professor of law at Harvard, also served as Solicitor General of the United States in the Kennedy and Johnson administrations and, later, as the first Watergate Special Prosecutor. His books include Cases in Labor Law, The Role of the Supreme Court in American Government, Civil Rights, the Constitution and the Courts, and Freedom of Expression. Cox will speak on "The Role of the Supreme Court in American Constitutionalism."

PERFORM AT FIRST
CHICAGO CENTER**

Phyllis Hurt, assistant professor of music, and **Ronald Combs**, professor of music, will be performing in Mostly Music Midday concerts at First Chicago Center in March. Phyllis Hurt, lyric soprano, joins with the Russian Folk Orchestra of the University of Illinois-Urbana in "The Russian Balalaika Ensemble," a concert featuring folk songs for instruments and voice on Tuesday, March 1. Dr. Hurt's background includes grand opera, musical theater, oratorio, recitals, as well as teaching. . . . Ronald Combs, director of Northeastern's Opera Workshop, will take the audience on a tour of comic opera in "Comic Opera--Old and New Style" on March 22. Featuring scenes from many different periods and styles of comic opera and music theater, the concert will conclude with a complete performance of Bohuslav Martinu's "Comedy on the Bridge." There will be costumed, narrated scenes and props, with Northeastern piano accompanist Jane Kenas providing the background music.

These Mostly Music Midday Concerts (brown bagging is welcome) are in the First Chicago Center, Plaza level, indoors, at Dearborn near Monroe. Doors open at 11:30 a.m. and the concert runs from Noon to 1:00 p.m. Admission at the door is \$2.50 per concert.
