## NEW TRANSCRIPT POLICY STARTS IN FALL

Effective in fall 1990, a \$10.00 transcript fee will be assessed for each student registering at Northeastern for the first time. This will allow students to request official transcripts up to a reasonable limit at no additional cost. Students who matriculated prior to fall 1990 will no longer be assessed a transcript fee. The new transcript fee will go into effect August 26, 1990. The current policy is a \$2.00-per copy fee. When the new policy starts, there will be no other charges for transcript requests other than the one-time \$10 fee assessed to new students.

## FROM STEPFAMILIES TO BLENDED FAMILIES

As stepfamilies have become increasingly common they are coming to be known by the term "blended families." Are you a part of a blended family? If you are you're one of many. In the United States there are 50 million adults and 15 million children living in blended family relationships. By 1990 there will be more blended families and single parents than "natural" families. For those of you about to enter such a relationship and for those of you already in one, it is important to note that living in a blended family is **not** like living in a biological family. There are important differences which require a different set of behaviors. Here are a few guidelines:

1. The biological parent comes with a ready-made alliance with the children. The natural tendency of the parent to align himself or herself with the children is a result of many years worth of memories. The parent, after all, began the relationship with the child the day it was born. The stepparent needs to understand this tendency and not define it as rejection or unfair treatment.
2. As a stepparent don't take the lead as a disciplinarian. There will be occasions when it can't be avoided, but, as a rule, the biologic parent should be in charge of discipline.
3. Show your affection with praise or pats on the back rather than hugs. Unless or until the child appears receptive to hugs -- don't. Hugs are great only when the "huggee" is as delighted as the hugger.
4. It's OK to feel anger, sadness, and resentment toward your stepchildren. Natural parents experience those same feelings so it is no surprise that a stepparent can resent the spouse's children. (Nor, of course, is it a surprise that children can feel resentment toward the stepparent.) What's **not** OK is to get lost in an "if only I didn't have to put up with the kids" fantasy. Instead of "if only" fantasies, attend to problem solving.
5. A suggestion for non-custodial parents and stepparents: young children often prefer to call the stepparent simply "mom" or "dad." Instead of signalling a rejection of the real mom or dad this usually is related to the awkwardness and discomfort a child feels when using the stepparent's first name. Calling a stepparent mom or dad will never, by itself, interfere with the child's relationship and love for his real mom or dad. And if you have your stepchildren's permission, introduce them as your **children**, not as stepchildren.

Working through the adjustments and problems of blended family living requires time, patience and care. If given that time and care, the members of a blended family can grow into relationships that are as close and nurturing as those in a natural family.
