

NEIU on the Road to Wellness

Ever wonder why you have an Athletics Fee on your bill but no athletics? Here's why.

NEIU is moving toward making the Physical Education Building into a Wellness Center, and the fee in part supports this transition, as well as paying for the tuition waivers of the few athletes who remained when NEIU dropped Division I Intercollegiate Athletics.


The Wellness Center concept can be viewed as a sort of private Health Club, complete with professional trainers and state-of-the-art equipment. The concept is expected by Director of Recreation Chad Good to be in place for the Fall '99 semester.

"This is a new beginning for campus recreation," said Good. The Wellness Center concept involves promoting healthy lifestyles for students, faculty and staff. In addition to having more access to the P.E. facilities, the introduction of club sports has begun and the search is beginning for staff experienced in assisting people in developing personal training programs, involving proper nutrition, wieght loss, work out and fitness programs tailored to the individual. Good also wants experts on staff to provide students with health assessments.

recreational use of students, faculty and staff. The only thing that might interfere with someone's private workout is the presence of a class.

Some of the club sports are getting underway in a little more than two weeks. For example, 3-on-3 Basketball begins January 26 at 1:45 p.m., the Free Throw Contest begins January 28 at 2 p.m., and the Spot Shot Contest begins February 2 at 2:15 p.m. Entries for the 5-on-5 Basketball Tournament, a huge success last semester, close on February 2, but playing times are yet to be announced.

The P.E. Building has a lot to offer students for their money, which they're paying anyway. There are two gymnasiums, a running track, raquetball courts, a huge swimming pool, locker rooms with showers and steam rooms, outdoor tennis courts and a state-of-the-art weight and conditioning room. 

Asbestos abatement closes additional passageways

On December 30, 1998, the east-west corridor between the Fine Arts Building and the Auditorium opened for pedestrian traffic. However, the east-west corridor north of the Auditorium and Bookstore will be closed for approximately three months. Access to the F-Wing and the Stage Center will be only from the south east entrance next to the Classroom Building. The diagram below indicates available corridors for use.



University's committment on sexual harrassment

It is the policy of Northeastern Illinois University that the sexual harassment of one member of the academic community by another will not be tolerated. This policy applies to all members of the campus community: students, employees, and visitors. It applies to incidents which occur on University property, as well as at offcampus functions sponsored or supervised by the University.

One of Northeastern's goals as a University is to foster an open learning and working environment free from sexual harassment and from the fear that it may occur.

Sexual harassment is against federal and state law: it is a violation of the Title VII of the Civil rights Act of 1964, Title IX of the denies, limits, provides different, or conditions the provision of aid, benefits, services, or treatment protected under Title IX." Finally, the growing body of case law also continues to refine the definition of behaviors which constitute sexual harassment.

There are two categories of behaviors which may constitute sexual harassment. "Quid pro quo" refers to situations in which a tangible benefit (a grade, a job, a promotion) is contingent upon the performance of sexual favors. This occurs in situations of unequal power such as supervisor/subordinate in the workplace or faculty/student in the classroom. the second category, "hostile environment," refers to patterns of behavior or incidents (including verbal, non-verbal, physical, or other) which may seem harmless as individual events, but which may be considering intimidating, hostile, or offensive when taken together. There is no comprehensive definition of those patterns of behavior which constitute a hostile environment: however, the 'reasonable woman" standard is often used to evaluate the environment in these situations. Although sexual harassment most commonly is found in situations of male supervisors or faculty harassing female subordinates or students, the prohibitions against sexual harassment also extend to women harassing men as well as to same sex harassment. In addition, sexual harassment of peers (employees harassing employees, non-supervisory employees harassing students, students harassing employees, and students harassing students), as well as sexual harassment of employees by non-employees, may constitute "hostile environment" sexual harassment.

characteristic of the Northeastern community, we need to be alert to the fact that behaviors are perceived differently by individuals from different cultural backgrounds. What is intimidating, hostile, or offensive to persons from one group, is not perceived in that way by others. Sexual harassment is unprofessional and unethical behavior in the university setting.

Intimate relationships between faculty and students as well as between supervisors and subordinates raise serious professional concerns. When one party has power over the other, the relationship is inherently unequal. the faculty member or supervisor cannot be certain that the relationship is truly welcome or consensus. If the relationship deteriorates, possible allegations of "quid pro sexual harassment may take individual action:

1. if you think that you will not be jeopardizing your personal safety, job, or academic status, communicate clearly and unambiguously to the offender that the behavior is not welcome and should cease immediately.

2. keep a written record of what happened and when it took place (include the names of any witnesses).

 seek advice on how to deal with the situation from the Office of Women's Services or the Affirmative Action Office. Northeastern is committed to:

a. promoting awareness and prevention of sexual harassment and its consequences, b. providing support services to victims of specific needs, and

c. some academic courses in Sociology and Women's Studies regularly include content on sexual harassment.

Support services available to victims of sexual harassment include:

a. the Office of Women's Services will discuss concerns about sexual harassment and help people explore their options for resolving a particular problem,

b. the Counseling Office (B-115, ext. 6269) provides private counseling for students, and c. the Employee Assistance Program (800-233-4960) provides counseling to employees.

Incidents of sexual harassment should be reported to the Affirmative Action Office (C-218, ext. 3375) for investigation and appropriate disciplinary action under the University Discrimination Grievance Procedure. If a responsible University official becomes aware of incidents of sexual harassment, the University may be legally obligated to pursue an investigation, even in the absence of a complaint. Complaints of sexual harassment against the President of the University may be filed with the Chair of the Board of Trustees of Northeastern Illinois University via the Board Liaison (C-212, ext. 3376) who shall take appropriate steps to investigate the complaints and to seek informal or formal resolution.

Education Amendments of 1972, and the Illinois Human Rights Act. The term sexual harassment as used by Northeastern Illinois University in this policy encompasses behavior described by the EEOC: "unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature constitute sexual harassment when (1) submission to such conduct is made either explicitly or implicitly a term or condition of an individual's employment, (2) submission to or rejection of such conduct by an individual is used as the basis for employment decisions affecting such individual, or (3) such conduct has the purpose or effect of substantially interfering with an individual's work performance or creating an intimidating, hostile, or offensive working environment." In addition, this policy includes the definition of sexual harassment as described in Title IX of the Education Amendments of 1972: "verbal or physical conduct of a sexual nature, imposed on the basis of sex, by an employee or agent of a recipient of federal funds that

quo" harassment may arise. Furthermore, others who perceive preferential treatment between the parties to the relationship may feel themselves in an offensive environment. Finally, a consensual intimate relationship poses a potential conflict of interest.

In situations in which an employee or student uses sex to improve one's employment or academic situation, the supervisor or faculty member is responsible for maintaining appropriate professional behavior.

Everyone in the campus community should be aware that sexual harassment complaints can be pursued through the oncampus affirmative action complaint procedures as well as through the courts. Although the University has institutional liability for sexual harassment which takes place on campus, under federal law there may also individual liability on the party of the harasser and the right of the victim to recover monetary damages from a harasser.

Members of the university community who suspect that they have encountered

sexual harassment.

c. thoroughly investigating alleged incidents of sexual harassment, and

d. disciplining student and employee perpetrators of sexual harassment. Investigations:

a. will be carried out pursuant to the University Discrimination Grievance Procedure,

b. will be kept as confidential as possible, and

c. may include the provision that permits the complaining party to avoid the alleged harasser while the investigation is ongoing.

A variety of offices provide services aimed at promoting awareness and prevention of sexual harassment and its consequences:

a. the Office of Women's services (E-047C or E-043, ext.3568) conducts workshops for employees and students and provides classroom presentations on request, b. the Affirmative Action Office (C-218, ext. 3375) provides workshops on sexual harassment on request and in response to Sanctions:

Following a determination of sexual harassment, the University may impose these sanctions against:

a. students - official warning, disciplinary probation, suspension, or expulsion; b. employees - oral and written reprimands, fines, suspensions, and termination; and c. visitors - prohibition from coming on campus, or other action to prevent contact with the victim of harassment.

Frankenstein food

They claim there are no dangers, but then schools not too long ago taught children that red meat on a daily basis was a necessary means of protein.

Now, excess red meat is charged as a villain of heart disease, cholesterol, and even cancer. Even whole milk, once considered something to strive on, had been replaced by skim milk. Growing kids are even encouraged to stay away from the "evils" of Vitamin D (whole), though that's not surprising in our overweight, unhealthy society. The point is that these are foods that people have been eating for years, and just now its come out that it just may not be the best for them.

Who knows what ten years from now will bring us, especially since these genetically engineered foods, are designed to fight off problems by producing pesticides and herbicides. Built in pesticides, yum sounds appetizing. If the people have a right to anything when it comes to consuming, that is the right to know what it is that they are consuming.

Once again, man tries to cheat to achieve perfection. When will they ever learn that nothing is perfect. People remember the old saying, "never mess with mother nature?"

It is the responsibility of big business, though, to make us aware of the changes they make to fresh fruit. The frightening thing is the fact that fresh will no longer be healthy.

Is faith in the Criminal Justice system faultering?

I wonder how much faith some people in our society have in regards to our criminal justice system. I for one have little faith in it, like to think of it as the unjust system. Some may agree with that assessment and others will not but here are the reasons:

Police and prosecutorial misconduct, juries convicting with little or no evidence, overzealous judges, incompetent defense attorneys, and having a system that is embedded with racism.

The saddest part of all this is when the extreme punishment in our system comes up, the death penalty that all these factors tend to come into play.

In November, while attending the Conference on Wrongful Convictions and the death penalty at Northwestern University School of Law, I thought that the Rolando Cruz case, which dealt with police and prosecutorial misconduct, was a rare case. Yet it happens at an alarming rate. There were 74 cases at the conference where the state said "you know what, we made a huge mistake."

In a vast show of unity, over thirty wrongfully convicted individuals attended the conference. On that Saturday afternoon, looking at those individuals, I could not help but think what an American tragedy was on that stage. The individual's state thought they took away their will to live, but they were wrong. The individual's state thought they took their courage away, but they were wrong. The individual's state thought they took away their overall strength, but they were wrong. Above all the individual's state thought they could take away their hope, but they were wrong. That Saturday session was the greatest show of strength, courage, will, and hope that has ever been seen.

Most are familiar with Rolando Cruz, Alejandro Hernandez, and the Ford Heights Four. But there are many others you may not have heard about. Walter McMillan, a black man accused of murdering a white woman in Alabama, was sentenced to death after a trial that lasted one and a half days. He had an air tight alibi (he was attending a church fund-raising event at the time of the murder). The mostly white jury failed to believe the twelve black witnesses who testified on his behalf. There is no reason that case should have gone to trial.

In 1976, Sonia Jacobs and her husband Jesse Tafero were sentenced to death in Florida for the murder of two policemen at a highway rest stop. A third co-defendant got life for testifying against the other two. Jacob's childhood friend, Micki Dickoff became involved and did some investigating. She discovered that the chief prosecution witness failed a lie detector test, a fact that was never revealed to the defense. Before this was discovered, Tafero was executed in 1990 by electrocution. The execution was botched to the point where flames shot up on his head. Fortunately, in 1992, Jacobs was released.

Joseph Burrows of Illinois was convicted of the murder of William Dulin in 1989. No physical evidence linked him to the murder. The prosecution's two chief witnesses recanted their testimony, one of them confessed to the murder. The other witness said he was coerced by prosecutors and police.


Andrew Golden, a high school teacher in Florida, was convicted of murdering his wife in 1991. In 1993, his conviction was overturned by the Florida Supreme Court. It held that the state had failed to prove that the victim's death was anything but an accident.

Gary Gauger of Illinois was convicted of killing his parents in 1993. There was no physical evidence linking him to the crime or any witnesses. In 1996, the U.S. District Court overturned his conviction, saying that authorities lacked probable cause to arrest him or subject him to twenty one straight hours of intense questioning. During a secret wire-tap investigation, the FBI stumbled onto the real killers, three members of a motorcycle gang. Gauger was released.

James Creamer, was sentenced to death in 1973 in Georgia for a murder allegedly committed with six other individuals. After an investigation by a local newspaper, a federal judge declared that the prosecution had withheld and destroyed evidence, a witness admitted that she had lied in court, and another man confessed to the crime. The convictions against all seven men were overturned, with all charges dropped.

This is only a small sampling of the cases against the wrongfully convicted. What about the ones still on death row or serving life sentences. Some are indeed innocent. In Illinois, since 1976, eleven people have been executed and nine others released because they were innocent. That is a terrible ratio. If any state needs to have a moratorium on executions it is our state. Ten men are on death row in Illinois for separate murders on the basis of a confession beaten and tortured out of them by then Police Commander Jon Burge, who has since been fired. How many of those are innocent?

What about those serving life sentences? Ellis Patterson, who is black, was convicted of the murder of a firefighter at a bank in 1992. Patterson was fifteen at the time. At his alleged confession, he was required by law to have a juvenile officer and his mother present. The police refused to allow either. There is no record of the confession anywhere, not on audio, video, or a written document signed by Patterson. All there is are the police officer's word that he confessed. His uncle turned him in for the reward money. He later recanted. His reasoning was that he thought he could make a little money but he never believed Patterson would be found guilty. Prosecutors did everything they could to downplay the trial to the media because of the extreme lack of evidence. No physical evidence, no witnesses, no murder weapon ever found. How in the world was he found guilty? For that police, prosecutors, and jury are to blame. How much faith do you have in the criminal justice system? I have very little. --. JOHN RANDALL



Record of the Year



Fareed not just some Haque guitarist Guitar virtuoso plays NEIU by Dave Grzelak REV Editor



Billed as an "internationally renowned guitarist," jazz/classical guitar virtuoso Fareed Haque became "international" before he picked up his first guitar. He was born to a Pakistani father and a Chilean mother and spent a good deal of his youth travelling to Chile, France, Iran, Pakistan, and Spain to visit family.

Exposure to these cultures revealed a spectrum of music that Haque still explores today. His performance at NEIU (January 22, Auditorium, 8:00 p.m.) promises to continue his history of stylistic diversity and virtuosity. His extensive history of live performances includes playing with the Minnesota and Milwaukee Symphony Orchestras, among many, and performing with other musical greats such as Dizzy Gillespie.

A glance at his album credits reveals important names in jazz and classical music. But his earliest credit may be his most famous: Haque played on Sting's 1987 album Nothing Like The Sun. Speaking of Sting, Haque also contributed his virtuosity to Bob Belden's 1991 album The Music of Sting.

Of the remainder of his 39 album credits, he has contributed to several more of Belden's albums as well as several of Paquito D'Rivera's works including the 1997 release Live at MCG that also featured the United Nations Orchestra.

He has also released six albums of his own including his latest, Deja Vu. Aside from all of his studio work, he also possesses another passion. "He loves baroque music," said Carol Kalzonjian, Haque's personal assisstant. Haque noticed there was a tremendous void involving one of his favorite kinds of music. He now is an active transcriber of both Baroque and South American music and uses them as part of his shows. "He played a recent concert on WFMT," Kalzonjian said. "Half of the pieces he played were his transcriptions."

And as if this wasn't enough, Haque has been teaching at Northern Illinois University since 1989. He is an associate professor and director of Jazz and Classical Guitar Studies. And while he has a free hour or so to squeeze NEIU into his itinerary, see him before he's gon ...


15th amendment fallacies

First I'd like to commend Jemimah Noonoo for actually getting involved in school activities and for recognizing the importance of being an active part of American democracy—both through the press and by being aware of issues that are important.

I hope I am not the first to tell you this since I didn't see your paper until a class on the 13th, but you have actually provided one of the best and clearest examples of why most papers check facts. As this is a student paper I guess it should be a learning experience.

Anyway, the 15th amendment (adopted in 1870) provides the rights for all American citizens to vote regardless of color. The voting rights act of 1965 was a move by the government to craft a law to address issues that had been covered by a number of supreme court cases. Much of what it did was guarantee that voters couldn't be turned away in any area of the country through the use of shady tactics-such as language requirments, reciting the constitution word for word, or poll taxes. The majority of this act is permanent law and will not be up for review in 2007. The part that will be up for review in 2007 is restrictions placed on certain areas of the country that are required to prove that any changes to local election laws are not being implemented to adversely affect minority voters. I believe each time to prove that any changes to local election laws are not being implemented to adversely affect minority voters. I believe each time it has come up in the past the areas covered have actually been expanded (1970, 1975, and 1982).

The belief that voting rights will end for some groups in the year 2007 is one of the many falsehoods that seem to increasingly pop

THIS MAN'S WORLD

COMMERCIAL THIS

It seems as if more and more I am seeing commercials that make absolutely no sense to me. They truly aggravate me because they somehow make me feel inadequate, as if I am the only one that is missing the clever pitch that is obviously aimed over my head.



The old commercials were at least artsy. They would typically begin with a young, barefoot girl sitting at a parkbench wearing jeans and a tube-top.
