The carpets have been removed and all the bookshelves are covered in clear plastic as the smell of soot still lingers in the air.

The Ronald Williams Library will remain closed until at least mid-February and possibly longer, according to Dean of Library Services Brad Baker, as clean-up efforts continue from the fire that occurred at the end of the past fall semester.

Director of Buildings and Grounds for Facilities Management, Ralph Zia told the *Independent* that the university has so far committed \$1.6 million to clean the library, but more may be spent. Zia said that the university's insurance will cover the bulk of the clean-up, minus deductibles. Zia did not know the value of those deductibles or if the university's insurance rates would be raised as a result.

"In addition to cleaning every surface in the library," said Baker, "the company that was hired to do the clean up, Brouwer Brothers Steamatic, cleaned one million plus books and other items in the library's collection."

The fire started in an elevator mechanical room in the basement of the library. Though the library was not damaged by fire, the library and its collection were damaged by smoke and soot. Baker listed for the Independent the work

lower level was damaged by the water, and new carpeting will be installed at the end of January.

Ceiling tiles on all five floors of the library have been removed and discarded. A contractor has been hired to replace the ceiling tiles with an estimated completion date late in January.

All electrical systems and controls in the mechanical room must be carefully checked and any damaged items replaced. This work has been underway for the past couple of weeks and will require a few more weeks

system sustained significant damage. Work is underway with those repairs, but completion will require a few more weeks," Baker said.

"Once all of the above repairs are completed, the university will bring in an industrial hygienist to certify that the library is fully safe and ready for occupancy," according to Baker.

A Jan. 5 memo sent to the university's Dean of the Library stated that additional computers would be set up in Student Union room 123 across from the library's temporary location on the first floor of the Student Union.

## Military recruiters' access to colleges challenged in Supreme Court

Protests greeted recruiters for the armed forces at NEIU job fair last fall

The Solomon Amendment mandates that universities receiving federal funds must grant students access to military recruiters.

Law schools challenged this amendment because the military's "don't ask, don't tell" policy is discriminatory. The U.S. Supreme Court will hear the case; a ruling should be made in the beginning of the new year.

Colleges and universities have the right to ban companies and organizations with discriminatory employment practices from recruiting students, though the status quo declares that colleges cannot ban the military from

on-campus recruiting if they receive money from the federal government.

Northeastern Illinois' hiring policies show a commitment to equality. According to the Equal Opportunity and Affirmative Action General Policy Statement, the university strives to "Recruit, hire, train, and promote persons in all job titles, without regard to age, color, disability, national origin, race, religion, sexual orientation, or gender."

These guiding principles are in conflict with the military's "don't ask, don't tell" policy on homosexuality.

Federal funds keep universities from infringing on students and employees' civil liberties. Universities do not want to break the law and have their funding revoked or

## Hillary's speech in Chicago full of irony

As she espouses the value of debate and dialogue, protesters are removed from crowd at Roosevelt University

Senator Hillary Rodham Clinton (D-NY) is the honorary chair of the American Democracy Institute (ADI), which held their First Leadership Development summit on Dec. 3, 2005 at Roosevelt University.

The ADI's goal, as stated on its web site, is to encourage youth to "address and debate important issues in their community." Senator Clinton was one of the many prominent politicians who spoke at the event. Also speaking at the event was Governor Rod Blagojevich.


Both these speakers have a connection to Illinois, as well as other states. Governor Blagojevich determines what happens in education, health care, employment and other issues in Illinois. Senator Clinton grew up in Illinois and reflected on her experiences while encouraging youth to engage in the political process.

"Chicago is where I first became engaged in the democratic process as a teenager. To see so many young people going through the same process, excited about getting involved in their communities and thinking about how they can affect change locally, nationally and beyond, is inspiring," said Senator Clinton.

However, not everyone at the event supported Senator Clinton's presence. event chanting "Hillary supports the war" and "troops out now."

Senator Clinton acknowledged the protestors and said "I am happy to discuss that issue with you at the end of my speech." "However," she also said, "I don't think these people want to hear from you right now." The protestors were then escorted out of the building by security and did not return.

In her speech Senator Clinton talked about ADI and the role young people have in politics: "Young people have a voice and the power to make this country and world a better place. Organizations like ADI are

critical in ensuring young people have the skills they need to affect change."

ADI also provided an overview of their organization and the summit. In their press kit, ADI said, "We're committed to engaging American citizens in a national conversation about our democracy and its meaning in the 21<sup>st</sup> century."

ADI also said what workshops were available and what they hope to accomplish "Workshop topics include skills-based sessions on civic engagement through technology; community activism and advocacy, and issues-oriented sessions on electoral reform; faith, values and public policy; the role of media in politics and the

environment and policy. Through these workshops and panels, the American democracy institute will identify programs, ideas and emerging progressive leaders for further training through our leadership development program."

## Activist apathy lets administrators off the hook

A new semester is upon us and the lack of action last semester by some of the campus leaders and usual rabble-rousers was a real disappointment. Many of those campus leaders are graduating and looking beyond this place, going out into the real world to either change that or go get a job—and not make waves.

NEIU saw aggressive campus activism last year and the year before, which culminated in a strike. One day President Steinberg's office was put under siege. On another day one group of students cornered Steinberg after the State of the University Address about gay rights.

At the same time, things so got heated in a Student Government meeting that students speaking out about mismanagement of Student Activity Fees were breaking down in tears and diving over tables. Public safety had to be called.

When H.O.M.E. (Heterosexual Organized for a Moral Environment) came to school that first time in 2003, the students demanded changes. Policies in the form of the student code of conduct and employee training were changed along with the policy on outside groups speaking in Village Square (or so many believed).

Positive change happened because students stood up loudly and clearly said, "We're mad as hell and we're not gonna' take it anymore."

That was last year. Last semester was different. Graduation happened, though many had to watch it on TV from a separate room due to a lack of tickets.

Some letters were written and students were upset, but Acting President Janet Fredericks said that she couldn't change the schedule as students proposed. Students suggested to break up the graduation by college, thus allowing more guests to attend, but Fredericks refused, stating she was only an "acting" president. Apparently graduation was not important enough to discuss in her weekly phone call to Steinberg.

Recently, the group NSAW, or NEIU Students Against the War (many members are also involved with the NEIU Socialists Club), were told they could not pass out flyers questioning the military when they were at a recruitment fair. This is a huge issue for the anti-war community and the members of NSAW and the Socialists.

One of the individuals directly involved told the *Independent* that there was a meeting with the VP of Student Affairs Melvin Terrell to discuss the matter, but

H.O.M.E. came back to school after many believed a moratorium had been imposed in direct response to their 2003 visit. Terrell said "It (the moratorium) existed in 2003; this is 2005. I can't tell you when it ended." Unlike in 2003 and early 2004, there were no large scale demonstrations protesting H.O.M.E.'s presence. Again, the administration's answer seems to have been accepted.

El Centro still has absolutely no parking. Even though parking is charged by credit hour, they pay full price for services they don't get. There are not even any letters to the editor regarding this issue, much less protests.

Bureaucracy hates change, so unless students pressure the administration, no changes will be made.

So, as the new semester begins, what will be heard in the halls? "We're mad as hell and we're not gonna' take it anymore?" Or "Oh my god, did you see 'American Idol' last night?"

I shudder to consider the answer.

### *Report* annual college edition ranks Northeastern

U.S. News and World Report released its annual America's Best Colleges 2006 edition. In past years, the publication ranked Northeastern first in racial diversity in the Midwest and second nationally. While the current issue still lists NEIU first for diversity in the Midwest, the university has slipped nationally.

Last year, U.S. News ranked NEIU second nationally for racial diversity, and though NEIU is only ranked regionally in this issue, 13 schools had higher racial diversity scores than NEIU nationally. Northeastern had a diversity index score of 0.68 out of

## Build it, and they will exchange their books on it

The Student Goverment Association's online textbook exchange is up and running after years of waiting

Over the past few years, college students throughout the country have been banning together to fight the high prices of textbooks. Students have started protests in Washington D.C., influenced congressional members, and conducted studies, all with the aim to make textbooks more affordable for students.

Northeastern's students have recently launched a web site that will allow students to sell each other textbooks for a cheaper price.

### The book exchange web site

Graduate Computer Science Student Abdul Basit created the web site under the guidance of Professor of Computer Science Marcelo Sztainberg, at the suggestion of Student Government Association (SGA) President Evelyn Nazario-Rose.

The recently launched web site, http://

www.sgabookexchange.com/, gives students the opportunity to buy and sell textbooks. One of the main benefits of the web site, explains Basit, is that the buyer "can schedule a meeting with the seller," thereby allowing the buyer to see the textbook before purchasing it, which is not feasible through Amazon.com or eBay.

The web site will not take any money from the students, but will instead serve as a

forum for students to interact. The intention is not to harm Beck's Bookstore, stressed Basit, but to give students more options when it comes to buying textbooks.

The web site is not strictly for selling and buying textbooks. Basit also incorporated a tutoring exchange board, or what he refers to as a "knowledge exchange board." Basit created this service based on his own experience:

"Last year, I was not good at mathematics

... I offered to teach programming for three hours and they will teach me mathematics for three hours."

After Basit personally experienced the success of this knowledge exchange, he decided to share his idea with the student body. On the web site, explained Basit, "you put in the subject you want to learn and what you are willing to teach." In addition, this exchange of skills does not necessitate the exchange of money, added Basit.

In addition to selling and buying textbooks and exchanging tutoring services, the web site also has a feature to help students establish study groups.

Basit worked on the web site as a "purely volunteer project. No one is going to make any money off it," he explained. While Basit and his two fellow computer science classmates created the web site to fulfill a requirement for a graduate class, their project will continue to serve the student body at

Northeastern.

### The evolution of the book exchange

Originally, the book exchange was started under former SGA President Lukash Dobryzinski.



Over thousand dollars was spent on it, according to current SGA President Nazario-Rose, but it was eventually terminated.

When Gary Gaspard succeeded Dobryzinski as president, the book exchange fell to the wayside. When asked about the termination of the book exchange. Gaspard told the Independent last year that "It was up for over a year. Not even one student used it."

Throughout Gaspard's presidency, Nazario-

Rose fought to have the program reinstated, for she personally witnessed numerous students ask for its reinstatement.

Now four SGA presidents later, Nazario-Rose made the phone call to the Computer Science Department that led to the launching of the book exchange web site. "All it took was a phone call," Nazario-Rose explained.


Nazario-Rose has worked on the issue of textbook prices throughout her years in the SGA and as previous IBHE student advisory


committee representative.

As previous vice president of the SGA, she helped Cuyahoga Community College circle a petition that culminated in a protest in D.C.; she personally collected 3,000 signatures in one week.

Due to student criticism and protests of textbook companies over the past few years, such as the one initiated by Cuyahoga, the federal government released a study by

decreased, but they do want to be able to voice their opinions freely in regards to on-campus recruitment.

Career Placement Assistant Director Barbara Cosentino said, "If [students] are serious about changing policy, they have to go to the top level. I have to do my job" when questioned about on-campus opposition to the Solomon Amendment. Northeastern cannot maintain itself

without federal funding, and the military claims it could not survive without oncampus recruitment.

The Wall Street Journal reports the military's recruitment goal is 180,000 per year with the looming pressure of the Iraq war. If the Solomon Amendment were struck down, the multi-billion dollar per year recruitment budget would greatly increase.

a possible 1.0, with its largest minority listed as Hispanic (30 percent).

The two universities ranked highest in diversity nationally were Rutgers University in New Jersey and CUNY Baruch College in New York, both with a diversity index score of 0.73. Both schools largest minority population was Asian.

The other area where NEIU made a strong showing was the low amount of debt with which students leave school with. In its category of universities with master's programs, NEIU ranked fifth in students leaving with the lowest debt, with only 29 percent of students having any debt, with that debt averaging \$10,941. That percentage of students leaving school with debt (29 percent) is the sixth lowest nationally. In the Midwest, only the College of the Ozarks had a lower percentage of students leaving with debt—at 21 percent.

NEIU's graduation rate is listed at 15 percent, one of the lowest rates. President Steinberg has argued that this rate does not paint a fair picture of NEIU as NEIU has many non-traditional students who take longer to graduate. The graduation rate of other schools in the area are Chicago State at 16 percent, Columbia College at 27 percent, UIC with a predicted rate of 55 percent and actual rate of 45 percent, and Northern Illinois University with a predicted rate of 47 percent and actual rate of 51 percent.

NEIU has a 70 percent freshman retention rate, a 17 to one student faculty to student ratio, has 43 percent of its students under 20 years old, three percent of its students over 50 years old, is listed in the fourth tier of schools.

NEIU also has a peer assessment score of 2.5 out of a possible five, and has one of the lowest alumni giving rates at three percent (it is not known if alumni and former Board of Trustees Chairman Daniel Goodwin's \$400,000 gift was calculated into this figure).

the Federal Government Accountability Office (GAO) in July of 2005 that investigated the high price of textbooks.

In response to the GAO's report, Illinois Lt. Gov. Pat Quinn began pushing an initiative to make textbooks more affordable and the Illinois Board of Higher Education (IBHE) student advisory committee released a report replete with recommendations to help students better afford textbooks.

Nazario-Rose had previously stressed to the *Independent* her desire to implement IBHE's recommendations at Northeastern. Her continuous work and research regarding exorbitant textbook prices has culminated in the launching of this web site.


While according to Nazario-Rose the first book exchange did not succeed due to lack of advertisement, both Basit and Nazario-Rose expressed their hope that student interest will help the book exchange web site succeed.

### 1480 W. Webster in Chicago.

Haptonstall worked for several years for Northeastern's WZRD Radio, serving for a time as general manager. He also worked for WBEZ's World View program and filed news reports nationally for the Pacifica Network's Free Speech Radio News.

Haptonstall also has a history in Central America, visiting El Salvador several times. Hapenstal first went to El Salvador as part of a course taught by former Justice Studies Professor Renne Golden. Students stayed in local's homes in remote villages—not in hotels.

Haptonstall later returned to El Salvador on his own to be an international election monitor. Hapenstal says he has seen the negative impacts of U.S. trade policies first hand in Central America.

Haptonstall talked to the *Independent* about his policy positions and ideas. "The first thing I will do as the representative of the citizens in the 5<sup>th</sup> District is proudly join the ranks of Representatives Schakowsky, Kucinich, Gutierrez, Jackson, Barbara Lee, and the other 60 plus members of the Congressional Progressive Caucus. Together we will work towards achieving the goals of the Progressive Promise."

Haptonstall said his goals in office would be "Fighting for economic justice and security in the U.S. and global economies, protecting and preserving civil rights and civil liberties, promoting global peace and security, environmental protection and energy independence."


Haptonstall also listed universal health care as a priority, as well as fairness in U.S. trade policy.

Haptonstall wants to work with U.S. Rep. Murtha who has called for the U.S. to get out of Iraq and is critical of Emanuel who is not. "It is an unjust and illegal war sold to the American people on a pack of lies ... Representative Emanuel continues to support the war in Iraq. When Representative Murtha came out for re-deployment of troops last November, calling for complete re-deployment in six months, Representative Emanuel stated, 'When the time is right we will have a position.'"

"The voters I talk with overwhelmingly say the time is now. The Chicago city council voted 29-9 calling for a troop withdrawal becoming the largest city in the U.S. to do so. On "Meet the Press" in 2005, the incumbent [Emanuel] said even after knowing there are no weapons of mass destruction he would have voted yes on the Iraq invasion, "said Haptonstall.

Rep. Emanuel worked as a policy advisor to President Bill Clinton before replacing Rod Blagojevich in the 5<sup>th</sup> District when Blagojevich ran for Illinois Governor. Emanuel's office did not return calls for comment from the *Independent* as of press



Chicago's elite used to invest in Chicago and participate in city functions. Until only a few years ago, Mr. Marshall Field III was chairman of the board


of the Art Institute of Chicago. However, this trend seems to be changing, with the possible exception of the Pritzger family and a few others.

My mom made great peanut butter and jelly sandwiches. It was always grape jelly that she used, and her method of application of the spreads was no doubt influenced by the Great Depression during which she grew up.

Being less frugal and artistic, she glopped the peanut butter in the center of the slice of bread, dumped some jelly (grape) on top of it, and then pressed another slice of bread on top, thus oozing the combined mixture out the sides of the bread. Never before had I seen the two ingredients mixed together in a brown-purple-colored cowpie sandwich.

The portions were, by comparison to my mom's, generous. Peanut butter stuck to the roof of my mouth and gathered on my chin and fingers, while grape jelly oozed onto my T-shirt and pants. This never happened with my mom's thinly spread, bread-slice secured, separately layered, tiered creation.

Mom was a great cook. She was a traditional homemaker. She made apple and cherry pies from scratch, using the fruit from the

Although it was nostalgic and brought back some memories, it just didn't taste the same. It was missing one ingredient.

It wasn't made with her love.


### The Festival of Lights is important MAILBAG



Listening to Reverend Kenny's CD, Believe What You Wanna Believe, is like closing your eyes and imagining yourself in a 1950's Nashville recording studio. This stuff, unlike today's electronically hyped up country "rock," is really old fashioned country and western music, as it was originally meant to be. Kenny D. Kozlowski, an ordained minister in the Universal Life Church of Modesto California, has produced a CD consisting of 13 songs, all written by Kozlowski, with the exception of "A Cheetah and A Cheater," which is co-written by Taylor Kozlowski. The CD reminds one of the roadside honky-tonks in which we hear this type of unadulterated music. Rev. Kenny also composed the music for all the songs, except for one composed by John Kozlick in "Don't Do Me This Way." Classic two-step songs, modulating between fast and slow tempo, are well supported with the driving electric guitar of Dave Mick and steady drums of Brian Chinino. Also included on the cuts are the banjo, mandolin, keyboard and accordion of Kozlick. Rev. Kenny's wailing, sometimes effectively strained voice, is also accompanied by Larry "Fish" Bevignani on bass, Jesus Edwardo Florido on violin, Nelson Santana on percussion, and Kozlick on acoustic guitar. In addition, the floating background vocals of Liz Berg can be heard



in several of the tunes.

From the foot stompin' "If Hard Liquor Could Cure Me" and "Long Freight Train," to the more personal "My Big Old Stupid Heart" and "I Wanna Love You Tonight," Rev. Kenny sings in a style reminiscent of Hank Williams or others of the Grand Old Opry. The CD, which is issued on the Music Loft label and is available at all of Rev. Kenny's gigs, is what one might consider a family effort (he thanks his wife and family in the introduction sheet). Stop into Star Gaze (5419 N. ## **Deal's Gone Bad and Lord Mike's Dirty Calypsonians** rock Midwest Skafest 2005

Ska is far from dead and has a sense of humor

A large, Jolly Roger pirate flag hung over the stage at the Metro as pints of Guinness were raised high in the air to the nearly unintelligible words coming from the mouth of Deal's Gone Bad Guitarist Dave Simon as he sang "Dread Rock" to the crowd of Ska fans.

Midwest Ska Fest 2005 featured a varied ensemble of music-from Skapone and Mustard Plug's punkish two-tone Ska, to the rock steady reggae of Deal's Gone Bad, to the comic Calypso-Ska of Lord Mike's Dirty Calypsonians. The show was an alcohol-fueled raucous good time that never took itself too seriously.

The show also marked the release of Deal's Gone Bad's latest CD, the Longest Happy Hour, a compilation of music from their three CDs: Large and in Charge, Overboard, and Guide to Boat Drinks and Cruse Cocktails. If a pirate theme seems apparent, it is. The CD combines the Irish influences of the Pouges and Flogging Molly with the old school Ska Reggae of Laurel Aitken and a strong punk sensibility.

Though the styles of Ska varied widely, the energy both in the crowd and on the stage did not. It was high and constant, though a bit more frenzied for the more punkish Mustard Plug, who put on a musically solid set of music, although it was not that original or remarkable. The strongest sets were definitely Deal's and the Calypsonians.

Deal's Gone Bad has been around for over ten years. Their horn playing used to be slightly out of tune, but the great song writing and Guinness and Makers Mark fueled antics and pirate spirit always made for a good show. The highlight of Deal's set came when former front man Mike Park, with his lower baritone, joined new vocal leader Todd "Corndog" Hembrook for a rousing version of "Pirates."

I had never seen a conga line at a Ska show until seeing Lord Mike's Dirty Calypsonians. The band featured much of the same alcohol fueled pirate spirit of Deal's Gone Bad, and many of Deal's former and current members. The difference between the bands is that while Deal's has a more straight-ahead punk sensibility, the Calypsonians are all about the theatrics.

The band all wore white slacks and red Cuban shirts, and they featured "the Two Carmens," two dancers dressed like Carmen Miranda. Musically they were generally tight, with a Hammond B3 sounding keyboard, congas, and a large horn section. Mike Park's crooner baritone voice fits many of the old calypso covers the band does.

Though many people may not think Calypso and Ska go together, there is a good deal of historical precedent for it. Ska luminary Laurel Aitken told the Independent that Calypso was one of his big influences back when he first came to England from the Caribbean

and started playing music-before it was even called Ska.

Chuck Wren, founder of Jump Up records, a local label which many of Chicago's Ska bands are signed to, said he got the idea to put Mike Park in a calypso band shortly after he left Deal's Gone Bad.

Wren described Lord Mike's Dirty Calypsonians as "the retirement home for Deal's Gone Bad," stating that as Deal's has increased its touring schedule nationally, some members of Deal's who do not want to tour as much have joined the Calypsonians. The Calypsonians include members of The Sonnets, Deal's Gone Bad, The Drama, Situation Normal, The Business, and the Max Weinberg Seven.

Midwest Ska Fest 2005 has proved that Ska is far from dead-and that it has a sense of humor.

## Aeon Flux is no Catwoman

Critics band together to hate Paramount's latest flick



If the critics are to be believed, Charlize Theron seems to be following in the footsteps of Halle Berry, an Oscar-winning actress who performs in an action film that turns into a flop. While *Aeon Flux* was far from the blockbuster Paramount had probably hoped it would be, it



Like Traffic, Syriana focuses on ral characters in small stories that are all somehow connected. Connex, an oil company, once had control over the oil fields in an unnamed country, until the country's foreign minister, Prince Nasir (Alexander Siddig), granted the rights for natural gas drilling to the Chinese after they outbid Connex, a move that upset America. Connex then initiates a shadowy merger with Killen, a smaller oil company that has drilling rights in Kazakhstan. After Connex loses the drilling rights to the Chinese, a migrant worker named Wasim (Mazhar Munir) is laid off and has difficulty finding work The Connex-Killen merger attracts attention from the Justice Department, and Bennett Holiday (Jeffrey Wright) is assigned by a Washington law firm to ensure that no reasons are found to block the merger. Bryan Woodman (Matt Damon), an energy analyst based in Switzerland, is hired by Nasir to become his energy advisor. Nasir wishes to break away from

American interests so his country can be fully independent. Bob Barnes (George Clooney) is a CIA field operative who witnesses the theft of a stinger missile while trying to pursue Middle Eastern arms dealers.

The stories intersect at different points in the film, and the use of such a technique shows how connected the entire oil industry is to terrorism. When this film was first announced, many immediately denounced it for being too liberal, without even seeing it. Quite the contrary. Gaghan does a great job of painting a broad picture of the oil industry, and although politics definitely play a part in the film, the movie never takes a liberal or conservative stance. The temptation for such a stance is obviously there, and there are points that can benefit either side of such a large debate. However, to simply denounce Syriana as being a liberal film or a conservative film misses the entire point of the movie. A film with such a great cast as this one makes it difficult to select the best performance, but George Clooney truly shines in this role. One can only hope that this is the film when Clooney finally gets the recognition he has deserved. Although the nominations have yet to be released, one is confident that Syriana will be a contender for the upcoming Academy Awards. Syriana is rated R and is currently playing in theaters.

is by no means as bad as Berry's horrid Catwoman.

The movie is loosely based on the MTV cartoon created by Peter Chung. Much has been changed concerning the story of *Aeon Flux*. In the original MTV series, Aeon Flux was a mysterious and amoral secret agent from the country of Monica. Episodes featured very light dialogue, lots of action and violence, and frequently ended with Aeon dying at the end of the episodes.

In the film, Aeon (Theron) is still a secret agent, but the Monicans are now a group of rebels trying to overthrow the government on a futuristic Earth. When Aeon is sent after the Chairman Trevor Goodchild (Marton Csokas), she discovers another mystery concerning her past, as well as the nature of the world she finds herself in.

Critics seem to have united against the film, and most of this hatred seems to deal with spite towards Paramount as opposed to being an actual examination of the film itself. *Aeon Flux* wasn't screened for critics, something they find annoying. Almost from the beginning, critics went into the film expecting to hate it, thus the excessive number of negative reviews.

However, *Aeon Flux* is nowhere near as bad as the critics would have you believe. The film certainly has its flaws. The dialogue in the movie is very stiff at times and comes off as a bit forced, and some of the secondary characters are not given enough development. With that being said, the film itself seems to suffer from the fact that it was marketed as a typical sci-fi action movie, which it is not.

There is quite a bit of action in the movie, but that is not where it ends. Director Karyn Kusama has created an intriguing world with *Aeon Flux* and brings up interesting scenarios. Drug-induced higher planes of existence, cloning and existentialism are very prevalent themes in the film. If anything, this film is more of a thinking man's sci-fi, comparable to films such as *Gattaca* and *Equilibrium* or the novels of Philip K. Dick.

There are interesting revelations as the film runs its course, and the one thing it suffers from more than anything else is a short runtime. The film would benefit immensely from an extra half hour or so because it barely begins to scratch the surface of the potential of the themes it explores.

Ignore the negative reviews and give *Aeon Flux* a chance. It is not what you will expect, so go in without any expectations. The film is rated PG-13 and is currently playing in theaters. Although at this point, you may have to wait for the DVD release.



The recent film from Director Rob Marshall (Chicago), *Memoirs of a Geisha*, has acquired quite a bit of controversy. Most of the controversy is due to the choice to cast Chinese actresses Ziyi Zhang, Li Gong and Michelle Yeoh in a movie centered around Japanese characters before, during and after World War II.

Adapted from Arthur Golden's novel of the same name, *Memoirs of a Geisha* is the story of Chiyo (Suzuka Ohgo), a poor girl from a small fishing village. With her mother's health failing, Chiyo and her sister, Satsu (Samantha Futerman), are sold off by their father. Satsu is sent to a brothel, but Chiyo is sent to an okiya, where geisha live and train.

The film follows Chiyo's life from childhood and the trials she faces in the okiya, particularly from the okiya's most prominent geisha, Hatsumomo (Gong). After an attempted escape, Chiyo's debt to the okiva's Mother (Kaori Momoi) is so great that she must be condemned to the life of a maid, since she's not worth the investment of becoming a geisha. One day, while depressed, an act of kindness from a wealthy businessman named Chairman Iwamura (Ken Watanabe) gives Chivo new hope. From there, Zhang takes over the role of Chiyo and the story follows her attempts to become a geisha in hopes of once again crossing paths with the Chairman. Hatsumomo's chief rival, Mameha (Yeoh) takes Chivo under her wing and trains her to become a geisha, eventually changing her name to Savuri.

passion into their performances. Zhang's interactions with both Yeoh and Gong are perfect, particularly during a heartfelt scene where Mameha tells Sayuri that they do not become geishas to pursue their own destinies. The passion exuded by the two actresses in this one scene is enough to bring a tear to one's eye. Watanabe, although lacking the same amount of screen time as the other three actresses, provides the same stellar performance, perfectly exemplifying the kindness and good nature of the Chairman.

The film is more or less a very faithful adaptation of Golden's novel. The novel is more in-depth than the film, obviously, going into more detail about Chiyo's life before she became a geisha, as well as describing what happened to her after the events of the film. Also, the relationship between Sayuri and the character of Nobu (Kôji Yakusho) is downplayed in the film, whereas it was a very large focal point in the novel.

Despite the controversy surrounding the casting of Chinese actresses, Marshall did indeed make solid decisions when he chose these actresses. Zhang, Gong and Yeoh are all extremely talented and they bring a lot of There are some other small changes and alterations between the novel and the film, which seem almost meaningless and without any logic behind the change.

While much of Golden's lyricism in his prose could not be preserved in the movie, Marshall instead conveys it through the beautiful cinematography. Of particular interest is Sayuri's dance scene, as well as the beauty of the gardens and the kimonos in the film.

In the end, Marshall found a good way to bring Golden's novel to the big screen, and while it is not a perfect adaptation, he still manages to capture the spirit of Sayuri's story, while preserving the beauty and majesty that made the book so popular in the first place.





The death penalty is an issue that sparks a lot of debate among people. Some people view the death penalty as being cruel, yet others view the death penalty as being justified. In an October 2005 Gallup Poll, 64 percent of Americans supported the death penalty.

Currently, the death penalty is accepted in 38 of the 50 states: Alabama, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, Florida, Georgia, Idaho, Illinois, Indiana, Kansas, Kentucky, Louisiana, Maryland, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, Ohio, Oklahoma, Oregon, Pennsylvania, South Carolina, Tennessee, Texas, Utah, Virginia, Washington, and Wyoming.

The other 12 states, which are Alaska, Hawaii, Iowa, Maine, Massachusetts, Michigan, Minnesota, North Dakota, Rhode Island, Vermont, West Virginia, and Wisconsin, have declared the death penalty to be unconstitutional, therefore outlawing



The state that has the highest number of executions in the U.S. is Texas, with a whopping amount of 355. Illinois ranks sixteenth in the amount of executions with a number of 12 executions. Since 1976, there have been 1,004 executions in the U.S.

The death penalty not only affects adults who have committed serious crimes, but also juveniles who have committed serious crimes. There have

or firing squad. Thirty-seven states use lethal injection; 386 people have been executed by this method. Ten states accept electrocution, and 152 people have been executed through with potassium chloride, which stops the beating of the heart.

Electrocution was first used in 1890. With this method, the inmate is strapped into a chair with electrodes attached to it. Then, the executioner pulls a handle and sends a supply of power between 500 and 2000 volts that last for about 30 seconds. This method continues until the inmate is dead.

The gas chamber was first used in 1924. Through this method, the inmate is strapped to a chair in a chamber that leaks in gas.

For the firing squad, five men are armed with a .30 caliber rifle. The armed men then fire at the inmate's heart that is marked with a circular white cloth. The inmate ends up dying of blood loss. The most recent execution by firing squad was in 1996.

Up until the 1890s, hanging was the most commonly used method of execution. In this method, the inmate is hung with a rope by the neck and then pushed off of a platform, leaving the inmate to hang in the air.

this manner. Five states use the gas chamber, and 11 people have been executed with this method. Two states use hanging, with a total of three people executed this way. Only two states use the firing squad, and have used this method to execute two people.

been 22 executions of juveniles in the United States since 1976. On March 1, 2005, case Roper V. Simmons stated that the death penalty for juveniles should not be allowed.

Women are also affected by the death penalty. As of July 5, 2005 there were 54 women on death row, which is 1.58 percent of the total death row population. Since 1976, only 11 women have been executed.

There are several methods of execution. The main methods of execution are lethal injection, electrocution, gas chamber, hanging,

In Illinois, the main method that is used is lethal injection, or electrocution if lethal injection would be declared unconstitutional.

Lethal injection was first adopted in Oklahoma in 1977. It was not until Dec. 2, 1982, however, that this method was first used on a death row inmate. With this method, the inmate is injected with sodium thiopental, a drug that is used to put the inmate to sleep. Then the inmate is injected with pavulon or pancuronium bromide, which is a drug that paralyzes the inmate. Finally, the inmate is injected

### Chicago to go smoke free

A nearly unanimous vote sealed the fate of Chicago smokers on December 7, 2005, as the smoking ban was approved. Following the lead of other major U.S. cities, the recent ban prohibits smoking in most public places of the city as of January 16, 2006.

Complications are bound to hunt a Chicago smoker. A \$100 fine (at most) will penalize one puffing at a CTA train platform or in a condominium lobby. Lighting up outside requires one to be at least 15 feet away from the entrance of any public building where smoking is prohibited. Coincidentally this now includes almost every building in the city.

A major portion of competing lobbyists and public interest groups are dismayed with a victory they feel is partial. Amid the support of Mayor Richard Daley, a compromise was made excluding bars, restaurants attached to bars, and taverns—until July 1, 2008. Unless a proper air filtration system is provided, which the officials say is unlikely, within the two and a half year period bars will also be putting their ashtrays away. Anyone encountering smoke in a public non-smoking place is liable to dial 911. Businesses and public places that unlawfully allow smoking will face fines of up to \$2,500 as well as a suspension or revocation of license for repeat violations.

Today, more than a quarter of the nation's population lives in a smoke-regulated community. Bans preside in Washington state, a number of cities in Texas, Ohio, Delaware, New York and California. Indiana's Marion County is two months away from going smoke free. Amongst other cities, Chicago suburbs are jumping on the smoke-free bandwagon: Deerfield has approved a ban that takes effect March 1, 2006; Des Plaines is holding a possible smoking ban discussion on January 11; and Lake County hopes to go smoke free by 2007.

Some argue that outlawing a legal product such as cigarettes in select environments causes for "a tyrannical takeover of property rights," exclaims one irate blogger on Daily Kos.com. However, in many places the matter is being presented as a workplace safety issue with second hand smoke being a dangerous contaminant.

The American Lung Association of Metropolitan Chicago, which strongly supports the ban, has scheduled a free one-hour Quit Tip Workshop insisting on now being a good time to quit. Reservations for an introductory session on January 13 can be made by calling 312.243.2000.

# **Tipping tips**

Tipping is generally considered to be a courteous action done after being helped or served by another person. Tipping can, however, be a confusing topic and questions can arise as to how much to tip and whom to tip, as many people have different opinions regarding tipping.

The main places that people leave tips are at restaurants. These tips are generally split between the headwaiter/waitress and the serving waiter or waitress. No less than ten percent of the bill should be tipped when the service is poor, 15 percent of the bill should be tipped for adequate service, and 20 percent of the bill should be tipped for excellent service.

There are many other places and people who can be tipped. Various different web sites list the following people who should be tipped: taxi or limousine drivers, hotel maids, bell hops, coatroom attendants, valet drivers, delivery men, hairdressers, shampoo people, manicurists, spa services, and bars, among many more.

Taxi or limousine drivers are generally tipped about 15 percent, with an extra dollar or two thrown in for getting to the destination within a timely manner or for helping with baggage.

Hotel maids are generally forgotten about in the tipping world. Maids have to do much work in order to keep hotel room cleans and sanitary. They have to clean up after vacationing people. Maids should be tipped about two to five dollars per night spent in the hotel room. Bellhops at hotels should be tipped about one dollar per bag or a minimum of two dollars if there is only one bag.

Coatroom attendants are usually found at large party gatherings or in public places. These people should be tipped about one dollar per coat being checked. Valet drivers should be tipped about two dollars for bringing the car around. Consider this: what is worse? Having to walk in the rain to the car or tipping someone to bring the car to you?

Food deliverymen go through a major job with having to locate the house and having to wait patiently while money is being found to pay for the food. These people should be tipped about ten percent of the bill and a minimum of one dollar for bills that are ten dollars or under. Fifteen to 20 percent of the bill should be tipped for large or difficult deliveries.

Hairdressers, manicurists, and spa service people are generally tipped about 15 to 20 percent of the bill. Shampoo people should be tipped two dollars for shampooing and drying hair.

Today, bars are the places to go in order to have some fun. Bartenders must deal with the loud noise and fun times that others are having while they are stuck working behind the bar. It is nice to tip bartenders 15 to 20 percent of the tab with a minimum of fifty cents per soft drinks and one dollar for alcoholic beverages.

A point to keep in mind, according to www.infoplease.com, is that tipping is not considered mandatory. It should be done at the tippers discretion and as a reward for good service.

## **Everything's** falling into



Any child from the '80s knows and loves Tetris. This videogame has been around forever and lived through many changes and spin-offs. It exists on every game system, or at least some form of it, and is one of the most popular games available for cell phones. However, not many people know its unique history.

The original Tetris was created by a Soviet man named Alexey Pajitnov in 1984. The actual video game was based on a children's toy in Russia called Pentominos, which contained several different shaped pieces that you had to fit into a box, a common theme in puzzle toys found around the world. It could first only be played on computers, in very simple dot-matrix form. It later was licensed to a company named Mirrorsoft in England. Spectrum HoloByte later released this "Russian puzzle game" to computers.


Eventually, after the game was bought and passed



around a bit, Tengen (a division of Atari games) bought what they thought were the rights to the game from Mirrorsoft, and produced two of Nintendo's early game systems, the original Game Boy and the NES (Nintendo Entertainment System).

Atari, who owned Tengen, did not like the hefty cut that Nintendo insisted on getting from all their games, and thus went solo, taking Tetris with them. They did this by reverse-engineering a special chip that prevented any thirdparty game from playing on the systems. Though Nintendo sued, Tengen managed to sell Tetris (and a few other games) for about seven years until Nintendo finally won the lawsuit and Tengen was forced to sell the game. This is why the version of the game commonly seen is the Nintendo version. Because the Tengen version is no longer made, it is considered a very rare collectors item.

This wonderful and popular game has spawned many incarnations, such as Tetris Attack, Tetris 3D, and even some non-Tetris games like Klax and Columns. It was even made into a board game called "Tetris Tower." No matter how many variations there have been, none will be as unique as its complicated beginning.



At seven years old, Yvonne Nieves' parents enrolled her in a dance class. This wasn't just any kind of dance, but the cultural translations of Puerto Rican folklore, as well as afro-Puerto Rican dance.

One type of dance, the Pomba, was veloped by slaves to transmit escape routes. Another type of dance held religious significance. All dances had meaning. They were all important to her culture, and at seven years old, she realized how truly important they would become to her life. "For me, at such a young age of learning, this form of dance was part of maintaining culture, and identity and history," said Nieves, now a fifth-year undergrad student. As she would soon find out, maintaining her culture would be a struggle she would continue to dance with for the rest of her life. "I feel that if a group of people lose their culture, they lose their identity, then they lose themselves," said the 22-yearold Anthropology major. "So culture's important to me because people need to maintain their culture. Find any way possible to keep their culture, because if not, they'll lose themselves and they won't know who they are."

## Let's Get Personal Culture club

As a Puerto Rican, she fears her culture is being stripped away from her. As gentrification pushes her and her people out of their neighborhoods, the city is building over their murals and developing condos in place of their homes. She realizes the critical fight she must wage in order to protect her culture.

"It's very, very important I help myself and others like me to continue to maintain culture and recognize it and learn about it," she said passionately.

As a young Puerto Rican student. Nieves

and the importance of Latino student faces at the university."

Nieves is not a single pioneer. This struggle at NEIU started 35 years ago, she said. Many programs came from the activism others before her, like the student clubs Union for Puerto Rican Students (UPRS) in 1971, Que Ondee Sola in 1972, ChiMexLa in 1975, the establishment of Proyecto Pa'lante and development of the El Centro campus. The most recent battles include the establishment of the Latino and Latin American Studies Chicago, we need a space, a sacred space for us, in which we can creatively and culturally express ourselves," she said while sitting in its recording room in the back.

Though Nieves will be graduating in May, she contends that her struggle won't end there. "I feel that whatever career I do end up stumbling upon, I know it will be in this community. And it will be for Puerto Ricans and Latinos. And it would be to strengthen our history, and our culture, and our identity 'cuz I don't want to lose

leads an active life strengthening her cultural community, which extends far beyond the borders of her home to her neighborhoods and her university. She's been working to teach her fellow Latinos about their culture and history, some of which has been forgotten or never taught at all.

This articulate young woman is a past editor of *Que Ondee Sola*, a monthly Puerto Rican and Latino magazine published here on campus. The name is translated as "to stand alone," which according to Nieves is derived from the meaning of the Puerto Rican flag in "it stands alone with no other flag."

Now, Nieves is co-editor of the magazine and writes about the Latino student struggle here at NEIU. "I like to write about Latino issues at the university because I think that we're always going to have issues about the Latino reality at the university," she said.

"We've been able to not lose that knowledge and that history, that past history Program, which is currently offered as a minor. it."
