Vets Facing Stonewall on Funds

On Thursday, March 5, 1981, the U.S. Vets Club sponsored a meeting between Veterans and the administration of Northeastern concerning a cut off of Veterans benefits. The cut off of funds is the result of a "compliance survey," a routine audit of 50 veterans completed by the Veterans Administration September 26, 1980.

The audit by the VA charges that Northeastern had two catagories of irregularities. In the first catagory, UNI is alleged not to have submitted incomplete and "R" (Registered but never withdrew) grades to the VA in 20 cases concerning 16 students. In the record catagory UNI is alleged not to have reported "W" (Withdrawal) grades for 12 students in 16 cases. The VA is now conducting a 100 percent survey of all veterans cases at UNI. Until the survey is completed Vets will not receive benefits.

According to the Vice-President of Student Affairs, Dr. Daniel Kielson, Northeastern had considered various forms of action in reply to the VA cut off. Among the possible actions were political and legal pre-However, Keilson ssure. states that the university was advised by political consultants that in the face of investigations into fraud and waste in the VA, no congressman or legislator wants to be identified with hampering the VA now that it has decided to do something.


Keilson stated at Thursday's meeting, "We're feeling the ripple effect of that, (the VA investigation

into fraud), but that's something that the VA has to deal with. And that is going to take months, but perhaps well over a year to resolve." Keilson separates the larger issue of VA from the situation at UNI and as recently as Tuesday, March 3rd, he said he was confident that there would be not interruption of checks to the

However, on Monday, Samuel Holmes of the VA said it was unlikely that veterans would receive their April 1st checks. At the same time Keilson met with the newly elected Student Senate President and Vice-President, Steve Gold and Gus Gramas to discuss the possibility of having Senate provide funds for emergency loans to veterans that depend on their VA check for food and rent.

At the U.S. Vets meeting on Thursday, many vets expressed their frustration with the system. A petition was passed out which cited the arguement that vets were being punished by the VA for something the VA is accusing UNI of doing.

Jim Duff, President of the U.S. Vets Club gave a rousing speech from a veterans view of the dilema. "What we have at Northeastern is a battle between two bureaucracies. The way I see it we have the administration on one hand saying that the VA is at fault and we have VA and congressman and representatives and everybody else saying well Northeastern's at fault. I as an individual veteran don't care whose at fault all I know is that April 1st from

all liklihood we will not receive a check. And I say that if one veteran has to hold off on his future and it affects generations to come because many of us here, I know I am, are first generations attending college. And if even one has to drop out it is too many."


No one knows what will happen in the future, although some veterans at the meeting discussed the possibility of applying pressure on their congressman to expediate the VA investigation.

Many also expressed their anger at the VA for not sending a representative to the Thursday meeting to which the VA was invited both to help answer questions and provide information needed by the vets.

Coalition Pushes To Increase Funds

Very much aware of the inherent implications of Governor James Thompson's recommended \$1.228 billion budget for higher education in 1981-82, the Student Senate, in a vote of 19-1-6, moved to establish a special, five-member committee. The committee has been formed at the request of Professors Mary Ann Schwartz and Mitch Vogel.

Chaired by Senator Alan Mlotek, the committee will investigate various ways and means of assisting and supporting Northeastern's efforts in a statewide coalition. All Senators, the other members of the committee are: Shirley Grabowski, Kent Anderson, Peter Bergus, and Robert Maniaci.

The coalition calls for a proposed student/faculty support network for Illinois Public University Education. The purpose of this coalition is to increase public awareness in hopes of bringing about a reconsideration by the Governor's office. Next month there is a planned trip to the State Capitol. In

order to put the pressure on legislators, faculty and students will do lobbying, as well as the petitioning and writing of letters.

According to Professor Margaret Schmid, president of University Professionals of Illinois Local 4100, the solution to the problem is to get more money. In order to bring this about, the proposed coalition calls for a joint effort in behalf of the following legislative program to achieve adequate funding for the Illinois public uni-

-an end to the Illinois Board of Higher Education (IBHE) policy of tying public university tuition to inflation.

-a tuition increase for fiscal year 1982 no higher than the increase in general revenue funding.

-full 10 percent dollar funding for the 10 percent recommended salary increase

-the full 8 percent increase for on-going costs recommended by the IBHE on January 6

-the 16-19 percent increase for utilities recommended by the IBHE on January 6

-the original 7.7 million dollars in program support recommended by the IBHE

This program would help students, faculty, and universities, while at the same time continue to serve the public interest in providing low cost, high quality educa-




